

Tool: MDS Section J Changes

The <u>MDS 3.0 version v1.8.11v2 final item sets</u> was updated June 7, 2023, and <u>draft RAI guidance</u> was released on April 3, 2023, and substantial changes were made to several sections. Changes to section J include the revision of the Pain Assessment Interview, including expanding questions to reflect pain effect on sleep, pain interference with therapy activities, and pain interference with day-to-day activities.

AHCA has created this resource document to help providers breakdown the changes. The information in this document outlines key changes to MDS Section J, Coding Instructions/RAI Guidelines for each item, and Actions to Consider for implementation across your facility. It is important to develop a training plan for your facility to ensure all staff impacted by the changes are trained in them.

Staff may present response options on a written sheet or cue card. This can help the resident respond to items. 		 the resident's own comment and providing related response options. This interview approach frequently helps the resident clarify which response option they prefer. If the resident, despite clarifying the statement and repeating response options, continues to have difficulty selecting between two of the provided responses, then select the more frequent of the two. 	 Ensure care plan is updated to reflect resident responses. Review and update current pain management policies to reflect new MDS Pain Interview questions. Review and update policies and processes to ensure they address how responses will be communicated with the team. Examine current processes to ensure they address training on revised interview process. Review and update QAPI plan to monitor these expanded questions and potential trends in pain.
J0500A Pain Effect on Function	J0510 Pain Effect on Sleep	 Read the question and response choices exactly as written. No predetermined definitions are offered to the resident. The resident's response should be based on their interpretation of frequency response options. If the resident's response does not lead to a clear answer, repeat the resident's response and then try to narrow the focus of the response. For example, if the resident responded to the question, "Over the past 5 days, how much of the time has pain made it hard for you to sleep at night?" by saying, "I always have trouble sleeping," then the assessor might reply, "You always have trouble sleeping. Is it your pain that makes it hard for you to sleep?" The assessor can then narrow down responses with additional follow-up questions about the frequency. This item should be coded based on the resident's interpretation of the provided response options for frequency. If the resident is unable to decide between two options, then the higher frequency. 	



J0500B Pain Effect on Function	J0520 Pain Interference with Therapy Activities	 Read the question and response choices as written. This item should be coded based on the resident's interpretation of the provided response options for frequency. If the resident is unable to decide between two options, then the assessor should code for the option with the higher frequency. Rehabilitation therapies may include treatment supervised in person by a therapist or nurse or other staff or the resident carrying out a prescribed therapy program without staff members present. Definition: Rehabilitation Therapy – special healthcare services or programs that help a person regain physical, mental, and/or cognitive (thinking and learning) abilities that have been lost or impaired as a result of disease, injury, or treatment. Can include, for example, physical therapy, occupational therapy, and cardiac and pulmonary therapies. 	
	J0530 Pain Interference with Day-to-Day Activities	 Read the question and response choices as written. This item should be coded based on the resident's interpretation of the provided response options for frequency. If the resident is unable to decide between two options, then the assessor should code for the option with the higher frequency. 	
J2800 Involving male or female organs	J2800 Involving genital systems	*This question was updated to be gender neutral.	n/a
