MDS Item Fields – All PDPM Case-Mix Adjusted Components

Table: Explanatory Notes:

- An "X" listed in the PDPM PT, OT, SLP, Nursing and NTA Component columns below indicate that the MDS Item Field identified in the table row is used to determine the case-mix classification for the respective PDPM component.
- MDS Item Field rows in grey with *italicized* text represent new items that will be added to the SNF PPS Assessments on October 1, 2019.
- MDS Item Field rows and column "X" with red text identify items with potentially "High-Impact" on the PDPM case-mix payment rate for the identified component. High-Impact" items for each component are identified as follows:
 - o PT/OT = Surgery during hospital stay prior to SNF admission and Function
 - o SLP = All items not related to surgery during hospital stay have similar impact,
 - o Nursing = Items that could qualify for the Extensive Services, Special Care High, and Special Care Low Nursing Component subgroups, items that impact the Depression and Function adjustors, and the HIV/AIDS diagnosis special adjustment.
 - o NTA = All NTA items identified with a value of two or more points on the NTA table.
- MDS Item Field rows in tan represent MDS item groups identified in CMS PDPM documentation and do not have data entry fields. The required MDS data would be entered in the sub-items listed below the item group identifier.
- Table cells with question marks '?' indicate PDPM Component MDS Items in I0020B require further clarification from CMS.

Claim HIV/AIDS Item Field – For NTA Comorbidity Score and Nursing HIV/AIDS Special Adjustor Calculations

Table: Explanatory Notes:

- CMS explains that the HIV/AIDS diagnosis information must be reported on the claim instead of the MDS because 16 states have laws that prevent the reporting of HIV/AIDS diagnosis information to CMS through the current assessment system and/or prevent CMS from seeing such diagnosis information within that system, should that information be mistakenly reported.
- Under PDPM, the presence of the ICD-10-CM code B20 code, reflecting an active HIV/AIDS diagnosis, would mean the addition of 8 points to the resident's PDPM NTA score used to determine the appropriate NTA Component case-mix payment rate, and an 18% positive adjustment to the PDPM Nursing Component case-mix rate as follows:
 - o CMS will utilize the existing claims reporting mechanism to determine a resident's HIV/AIDS status for the PDPM NTA classification and Nursing rate adjustment. Specifically, HIV/AIDS diagnosis information reported on the MDS would be ignored by the GROUPER software used to classify a resident into an NTA case-mix group. Instead, providers will locate the HIPPS code provided to the SNF on the validation report associated with that assessment and report it to CMS on the associated SNF claim.
 - Following current protocol, the provider would then enter ICD-10-CM code B20 on the associated SNF claim as if it were being coded to receive payment through the current AIDS add-on payment. The PRICER software, which CMS uses to determine the appropriate per diem payment for a provider based on their wage index and other factors, would make the adjustment to the resident's NTA case-mix group based on the presence of the B20 code on the claim, as well as adjust the associated NTA Component per diem payment based on the adjusted resident HIPPS code.
 - o Like the NTA adjustment for residents with HIV/AIDS, the Nursing Component adjustment will be identified by ICD-10-CM code B20 on the SNF claim and would be processed through the PRICER software used by CMS to set the appropriate payment rate for a resident's SNF stay. However, for the Nursing Component, a 1.18 adjustment multiplier would be applied to the unadjusted base rate for the Nursing Component to determine the appropriate per-diem payment rate.
